The threshold for basic income (where you are not responsible for paying MLS) is \$90,000 for singles and \$180,000 for families. Income and affordability If your income is so low that you are not required to file your tax return, you will be automatically exempt from the penalty. For example, if a single taxpayer's income in 2018 is less than \$12,000, it was usually not necessary to submit a return; for married couples, the cutoff is \$24,000. \$24,000.
